Quality, Health Safety and Environmental (QHSE) Policy

- Ensure that all operational health, safety and environmental aspects of work are planned, documented reviewed and communicated and that hazards relating to routine and non-routine works are adequately risk assessed and controlled.
- Provide personal protective and other equipment to our employees as is necessary to enable them to carry out work
- Reduce waste through re-use and recycling and by purchasing recycled, recyclable or re-furnished products and materials where these alternatives are available, economical and suitable.
- Promote efficient use of materials and utilities resources throughout our facility including water, electricity, raw materials and other resources, particularly those that are non-renewable.

- Avoid, limit or substitute hazardous materials and products, and take all reasonable controls and actions to protect human health and the environment when such materials must be used, stored and disposed of.
- Purchase, issue and use environmentally responsible products accordingly.
- Ensure all company vehicles meet required emission standards and are maintained.
- Limit to and strive to eliminate or minimize emissions to the atmosphere which may result as a consequence of our work.
- Lessen the impacts of any nuisance noise and to work within set hours in residential areas.
- Where required by legislation or where significant health, safety or environmental hazards exist, develop and maintain appropriate emergency and spill response programmes within our Safety Health and Environmental plans.
- Communicate our health, safety and environmental commitment to clients, customers and the public and encourage them to support it.
- Strive to continually improve our quality, health, safety & environmental performance and minimise the social impact and damage of activities by periodically reviewing our QHSE policy in light of our current and planned future activities.

The Company is committed to the monitoring and continual improvement of safe systems and environmental performance.
